## Dr. Gary Elkins, Ph.D., ABPP, ABPH



**Dr. Gary Elkins** is a Clinical Psychologist, President of the Society for Clinical and Experimental Hypnosis, and incoming Editor-in-Chief of the International Journal of Clinical and Experimental Hypnosis. Dr. Elkins is an internationally known expert in clinical and experimental hypnosis and the co-author of the publication Standards of Training in Clinical Hypnosis and has multiple clinical research publications.

Gary is a Professor of Psychology and Neuroscience at Baylor University. He is Director of the Mind-Body Medicine Research Program conducting NIH funded research into clinical applications of hypnosis. In addition, he maintains a part-time private practice. His research and clinical work has focused on areas such as the role of the therapeutic relationship in hypnotherapy, mechanisms of action, pain, sleep, hot flashes, and stress.

Gary is the author of four books that are highly relevant to his workshop and clinical practice, *The Handbook of Medical and Psychological Hypnosis: Foundations, Applications, and Professional Issues*; *Hypnotic Relaxation Therapy: Principles and Applications*; *Complementary and Alternative Medicine for Psychologists: An Essential Resource*; and *Relief From Hot Flashes: The Natural, Drug-Free Program to Reduce Hot Flashes, Improve Sleep, and Ease Stress*.

Dr. Elkins is a renowned expert in clinical hypnosis and President of the Society for Psychological Hypnosis (Division 30 of the American Psychological Association). He is also Past-President of both the American Society of Clinical Hypnosis and the American Board of Psychological Hypnosis. Gary holds the Diplomate in Clinical Hypnosis from the American Board of Psychological Hypnosis (ABPH) and the Diplomate in Clinical Health Psychology from the American Board of Professional Psychology (ABPP). He has served as Vice-Chair of the International Society of Hypnosis Council of Representatives and has taught courses nationally and internationally on clinical hypnosis.

## Teaching and Consultation in Clinical Hypnosis: Train the Trainer Dr. Gary Elkins

Teaching and consultation in clinical hypnosis is enhanced by familiarity with the Standards of Training (Hammond & Elkins, 1994; Elkins & Hammond, 1998), formulating learning objectives, skill in leading small group practice sessions, ethical guidelines, consideration of Certification in Clinical Hypnosis, and providing case consultation.

This session will provide an overview of the current Standards of Training and continued application. The integration of emerging clinical research and clinical methods will be discussed. Also, some considerations in conducting small group practice sessions will be discussed with clinical examples and ethical considerations during clinical teaching.

In the second half of this session on teaching and consultation in clinical hypnosis, participants will have an opportunity to share their experience and time will be allotted for question and answer as well as role play as may be relevant to the discussion.

- Discuss Standards of Training in Clinical Hypnosis
  - The development and formulation of learning objectives
- Integration of emerging clinical research and clinical methods into teaching clinical hypnosis
- Conducting Small Group Practice Sessions
  - The mechanics and what to look for in participants during interactions, hypnotic inductions, alerting, and ethical issues that can emerge in sessions
- Case consultation and learning contracts

#### II. Question and Answer: Discussion Session

- Bring your questions and ideas for training in clinical hypnosis
- Beginning to Advanced levels of training
- Discuss challenges to training new professionals in clinical hypnosis
- How to integrate emerging knowledge, trends, and evidence-based practice and research informed interventions into clinical hypnosis training.
